Extension of DGR Global Loan Facility

Further to its previous announcements of 31 March and 31 May 2016, Armour Energy Ltd (**Armour, ASX: AJQ**) wishes to provide the following update in respect of the bridging loan facility (**DGR Global Loan Facility**) provided by DGR Global Ltd (**DGR, ASX: DGR**).

Extension of DGR Global Loan Facility

Armour is pleased to advise that it has secured an extension of the DGR Global Loan Facility to 30 September 2016 (**New Termination Date**). This two month extension has been agreed by DGR on the current terms of the facility which is secured and has an interest rate of 15% per annum. All other key terms of the DGR Global Loan Facility remain as previously advised.

DGR and Armour have today executed a variation to give effect to this extension.

Armour continues to progress negotiations with other third party / commercial financiers, and will update the market as and when able to do so.
